



MINUTES OF THE MUNCY BOROUGH COUNCIL MEETING

APRIL 6, 2017

**Motion** by Ed Feigles to appoint Elaine McAleer as temporary secretary was second by Dana Bertin. All were in favor. Motion carried.

President Baker called the meeting to order at 7:00 p.m., followed by the Pledge of Allegiance.

**Motion** by Ed Feigles to accept the minutes of March 16, 2017 as presented, was second by Dana Bertin. All were in favor. Motion carried.

**Unfinished Business:**

Muncy Resiliency Project Update: To date the Williamsport Sun-Gazette has dedicated five articles on the Resiliency Project to support public awareness. Lycoming County has scheduled a public meeting for Tuesday, April 25, 2017 at 6:30 p.m.

**Treasurer's Report:**

Green Street Park - Check # 1007 in the amount of \$156.00. **Motion** to accept was made by Linda Stein. Second by Ed Feigles. All were in favor. Motion carried.

**Motion** to accept the Treasurer's Report in its entirety was made by Dana Bertin and second by Ed Feigles. All were in favor. Motion carried.

It was noted that the 2016 audit is complete. The DCED report was filed in a timely manner.

Multi-Municipal Comp Plan Review – There are currently six issues the Multi-Municipal Comp Plan Review will address. These issues are 1) water quality, 2) flooding, 3) multi-modal transportation, 4) fragmentation of local government, 5) downtown revitalization, 6) land use regulations. Council members are asked to notify the review board if there are other issues they feel should be incorporated in the 10-year plan.
