Street sweeping for the year is complete. Approximately, \$2600.00 was generated from out sourcing the sweeper service. As always, the sweeper will be overhauled this winter at the cost of approximately \$6000.00. To purchase a new vacuum type sweeper would run around \$350,000.00 and require a CDL license. A street sweeper that would not require a CDL and would be similar to what the borough currently uses cost \$275,000.00.
