

Muncy Borough Council Minutes
January 5, 2026

The Meeting of the Muncy Borough Council was called to order in the Library/Media Center of Muncy High school at 5:00pm by Mayor Craig Scruggs. The Pledge of Allegiance followed.

Council welcomed newly elected Mayor Craig Scruggs, Councilman George Henry and Councilwoman Cindy Appleman. Mayor Scruggs issued the Oath to Cindy Appleman.

Dick Sutton made a motion to appoint Logan Laidacker as the Vacancy Board Chair. George Henry 2nd the motion. Motion carried.

Dick Sutton appointed Katie Hakes to Secretary/Treasurer. Ryan Scruggs 2nd the motion. Motion carried 5-0.

Ryan Scruggs made a motion to appoint Katie Hakes as the Right to Know Officer. 2nd by George Henry. Motion carried 5-0

Dick Sutton made a motion to appoint Chris Kenyon as the borough Solicitor. Cindy Appleman 2nd the motion. Motion carried 5-0

George Henry made a motion to appoint Todd Pysher to Borough Engineer. Cindy Appleman 2nd the motion. Motion carried 5-0

Dick Sutton made a motion to appoint Victor Marquardt and CODES, INC as Zoning Officer, Code Enforcement Officer and Building Code Official. Ryan 2nd the motion. Motion carried 5-0

Dick Sutton made a motion to appoint Tara Ashby as new council member. Tara is the only person who submitted a letter of interest to the board. Cindy 2nd the motion. Motion carried 5-0 (Resolution 2026-02).


