Dick Sutton made a motion to approve the April 15, 2026 and April 28, 2026 Minutes. Cindy Appleman 2nd the motion. Motion carried.

Ed Feigles made a motion to approve the check disbursements and bank balances. Dick Sutton 2nd the motion. Motion carried.

Old Business:

Borough Building – Nothing to report

Dick Sutton made a motion to donate \$500 to the American Legion Post 268. Cindy 2nd the motion. Motion carried.

Dick made a motion to accept the bid from Danville Area School District of \$11,111.11 for the Tahoe. George 2nd the motion. Motion carried.

Ryan made a motion to approve the cost of \$20.00 a month for a GIS software. (Diamond Maps). Cindy 2nd the motion. Motion carried.

Manager Report:

Spring clean up days were April 22nd and 23rd. 125 W Water St was cleaned up and the property owner will be billed for all costs associated with the clean-up. As budgeted, Muncy Borough sent a \$3500 donation to the Muncy Pool. The Memorial Day parade is scheduled for May 25th at 11am. There was a brief discussion between Marco Colbert and Council about e-bikes and electric scooters.

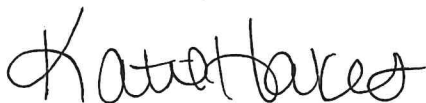
Tyler Thompson gave council an update on the first Fourth Friday kicking off this Friday. The Water Tower was taken down over at Youngs in April.
